WTO-TFA / NTFC Survey Results 84% of the respondents were satisfied of their interactions with their NTFCs ("3 or above" on a scale from 1 (poor) to 5 (excellent)). Yet, several suggestions to improve interactions were put forward More accuracy in the topics discussed at NTFCs need to go beyond information sharing → the NTFC, having agenda items that are followed through and completed, as well A seat dedicated to the they need to be able to private sector in the NTFC. as faster follow-up actions after process changes and discussions within the NTFC. enact them. #### **Conclusions / Recommendations**



- Calling for relevant private sector actors' involvement to speed up the national implementation of the WTO-TFA.
- Some NTFC as being established "in surface only" and require a deeper engagement and involvement from all the stakeholders.
- More detailed NTFC's agendas, with clear goals, processes and metrics for measuring outcomes.
- Consulting stakeholders directly involved on the ground at various stages to assess and inform them of best practices.
- Some of the commitments might not be specific enough, potentially creating misalignment in the harmonisation procedures.
- Noting the potentially detrimental effects of having a NTFC Chair constantly changing.
